Evaluation after a year of cooperation.



- broadening the knowledge of the risks associated with the Internet

Participation in the project had a significant impact on expanding the participants' knowledge about the risks associated with using the Internet. Particular contribution was made by the knowledge of partners from Cyprus who specialize in researching various threats related to the Internet.

- the level of knowledge about legal regulations related to the use of the Internet



Part of the project activities was focused on getting acquainted with the legal provisions that regulate the use of the Internet. Project participants significantly expanded their knowledge on this subject.



- broadening the knowledge about youth behavior on the Internet

A set of surveys examined the behavior of adolescents on the Internet. Getting

to know the results of these surveys broadened the knowledge of the participants and helped in the preparation of issues that will be included in the application, which will be the main product of the project.



- broadening the knowledge of teachers' awareness of the use of the Internet by young people

- level of satisfaction with the results of work on IO1



Partners rated highly the level of work on IO1 results. The work focused on

determining the level of knowledge about the risks associated with the Internet, legal regulations related to the use of the Internet, didactics of teaching Internet safety and the use of serious games to teach safety on the Internet.



- involvement in the tasks

The level of involvement in the implementation of tasks was assessed. Most of the partners highly appreciated their involvement in the project implementation.

- the level of communication in the partnership



Research on the level of communication in partnership has shown that there are some disturbances in the flow of information. Therefore, an online meeting was conducted, during which the rules of communication in the consortium were recalled, the main channels of communication and the obligation to systematically inform about all problems were reminded.



- level of satisfaction with promoting the project and disseminating the results

Most of the members of the project teams are satisfied with the promotional and dissemination activities carried out so far. The project partners plan to intensify these activities in the second year of the project, when the application teaching safe behavior on the Internet is ready.

Summary

Evaluation studies have shown that the project has a significant impact on increasing knowledge about the dangers of using the Internet. Thanks to the conducted research, it was possible to identify the areas of threats related to the use of the Internet. Thanks to the interviews and surveys, the recipients of teachers and students were, it was possible to draw conclusions about the approach to the Internet. Sources of information on legal regulations related to the use of the Internet were also studied.

The research also gave us a broader understanding of youth behavior on the Internet, which made it easier to identify the areas of threats we want to work on. Thanks to conversations with teachers, we know that they have problems with teaching safety in the use of the Internet and need new sources of knowledge, materials and tools.

The project teams are satisfied with the structuring of knowledge on the application of serious games in education and the approach to online safety teaching in partner countries, which was the main goal of IO1 activities. There is also a high level of satisfaction with promoting the project and disseminating the results so far. School and academic youth were also involved in these activities.

Cooperation in the partnership at the level of communication required an intervention. We expect that thanks to the measures taken, there will be no more disturbances in this area.
